

**Aseemanand acquitted in Ajmer blast case**

Jaipur, India, Mar 8, 2017 -- In a major relief for Swami Aseemanand, a special National Investigation Court (NIA) on Wednesday acquitted him in connection with the 2007 Ajmer blast case. Aseemanand was accused in the Ajmer blast case as per the NIA's chargesheet filed in 2007. The agency accused Aseemanand of hatching the conspiracy of bombing Khwaja Moinuddin Chishti shrine, thereby killing three people and injuring 17 others.

2007 Ajmer Blast Judgement

SCENARIO**2007 Ajmer blast case: Swami Aseemanand acquitted, three people convicted**

Jaipur, India, Mar 08, 2017 -- A Jaipur court on Wednesday convicted three persons but let off former RSS member Aseemanand and six others in the 2007 Ajmer Dargah blast case in which 26 witnesses turned hostile. The quantum of punishment will be decided on March 16. Three persons were killed and 15 injured in an explosion at the famous shrine of Sufi saint Khawaja Moinuddin Chisti in Rajasthan's Ajmer on October 11, 2007. NIA court judge Dinesh Gupta found Rashtriya Swayamsevak Sangh members Sunil Joshi and Devendra Gupta guilty of planning the blasts -- one of the two bombs didn't go off -- and Bhavesh Bhai Patel of planting the explosive. The court acquitted Aseemanand, also an accused in the Samjhauta Express and Mecca Masjid blasts, and others, giving them the "benefit of doubt".
