What to expect from Union Budget 2017



India, Jan. 2, 2017 -- Business will begin early for the Parliament next year. With the winter session proving a washout, and the deadline for the Goods and Services Tax (GST) looming, the government could convene the budget session of Parliament as early as the second week of January. The Union Budget itself will be presented on February 1.

I expect a rash of people-friendly announcements in the budget. The narrative around demonetisation — the government's move on November 8 to render invalid all old Rs 500 and Rs 1000 denomination currency notes, 86% of the cash in the system — is turning negative in parts, although it is a measure of the goodwill Prime Minister Narendra Modi still enjoys that most Indians continue to put up with the fallout because they think it is well-intentioned.
