Uphaar tragedy: SC sentences Gopal Ansal to one-year jail term

New Delhi, Feb. 9, 2017 -- In a majority verdict, the Supreme Court (SC) on Thursday sentenced Uphaar cinema owner Gopal Ansal to one-year imprisonment in relation to the tragic fire that broke out at the cinema that killed several people in 1997. Reviewing the 2015 judgment partially, justices Kurian Joseph and Ranjan Gogoi agreed on Gopal Ansal's imprisonment and directed him to surrender within a period of

four weeks. Justice Adarsh Goel under his dissent, did not wish to review the earlier order.

Delhi Uphaar tragedy: Victims' kin say SC order brings little relief



India, Feb. 9, 2017 -- Shekhar Krishnamoorthy, who lost his two children in Uphaar cinema fire nearly 20 years ago, expressed dissatisfaction over the Supreme Court judgment on Thursday.

Though the court ordered real estate baron Gopal Ansal to serve one year in jail and surrender within four weeks to serve the remaining term, his brother and Sushil Ansal was awarded a term that he has already served, including the remission, in the case.

"We are very disappointed. There is no difference between the latest judgment and the verdict in 2015. The court has let off Sushil on the basis of his aging and medical condition. It is unacceptable. We know how many aged criminals have been languishing in jail for years. Why such relief was granted to him? This is an accused friendly system," he said.
